RELEASE OF LIABILITY FOR MINOR PARTICIPANTS

READ BEFORE SIGNING

2. FOR MYSELF, SPOUSE, MY CHILD'S LEGAL GURADIAN AND CHILD, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASE or others, and assume full responsibility for my child's participation; and
3. I willingly agree to comply with the HSJPSA and JPS Hawaii stated and customary terms and conditions for participation. If I observe any unusual significant concern in my child's readiness for participation and/or in the Organization for which we have registered and participate with, I will remove my child from participation and bring such attention to the HSJPSA and JPS Hawaii Official immediately; and,

I myself, my spouse, my child's legal guardian, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE the HSJPSA and JPS Hawaii and their respective officers, affiliates, agents, representatives, successors, sponsors, advertisers and if applicable, owners and leasers of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to my child's involvement or participation in the HSJPSA and JPS Hawaii sports programs, events and activities, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEESS OR OTHERWISE, to the fullest extent permitted by law; and,

I, for myself, my spouse, legal guardian, my child, and on behalf of my/our heirs, assigns, personal representatives and next of kin, HERBY INDEMNIFY AND HOLD HARMLESS all the above RELEASEES from any and all liabilities incident to my involvement or participation in the HSJPSA and JPS Hawaii sports, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law; and,
6. I certify that my child is physically fit to take part in all HSJPSA and JPS Hawaii sports programs, events and activities; and,

I pledge my child's compliance to any and all HSJPSA and JPS Hawaii rules and understand that my child could be dismissed from the HSJPSA and JPS Hawaii sports programs, events, and/or activities for any conduct not in the best interests of the HSJPSA and JPS Hawaii and that no part of my child's membership and or registration fee will be refunded; and,
